

PRESIDENT'S MESSAGE

In 1859, Charles Dickens published *A Tale of Two Cities*, which begins:

As you read this issue of the MCPSRA Newsletter we are all "recovering" from one of the nastiest political seasons I can remember. I have (almost) lost lifelong friends and have avoided many conversations with others over the rhetoric and passion of the past several months. However, now that the election is over, I am confident that the great strength of our democracy will rise to affect a smooth transition of power and we will all be able to move forward.

The Holiday season is almost here, and a fresh New Year is at hand. So, let us all take a deep breath, exhale with a sigh of relief, and move into 2017 together.

Our organization stands on a firm four-point footing: our commitment to ourselves and all retirees; our commitment to the students and staff of MCPS; our commitment to our community; and our commitment to see MCPSRA and MRSPA grow.

So, what will 2017 bring for us and our organization? More information on each of these activities is contained in this newsletter. We will continue to enjoy ourselves and each other's company through participating in our trips and luncheon programs. [Also detailed in other parts of this newsletter]. We will work to grow our membership by reaching out to

other retirees. This year we will begin distributing the newsletter electronically as well as by US Mail in an attempt to be more timely and cost effective.

Finally, as I discussed in previous newsletters, this is an election year for MCPSRA. We will be electing officers who will serve for the next two years, beginning in July 2017. MCPSRA-HENSON PROJECT

The MCPSRA has resolved to help support the establishment of a museum and education center at the Josiah Henson Park in North Bethesda.


Josiah Henson was a very famous resident of Montgomery County. He lived here from 1795 to 1830 as a slave on the Isaac Riley Plantation near the intersection of what is now Old Georgetown Road and Tilden Lane. The Park is located on a small part of the property where Josiah Henson lived.

In 1849 Henson became one of the most influential international figures of the 19th Century when his autobiography was published. It was entitled *The Life of Josiah Henson, Formerly a Slave, Now an Inhabitant of Canada, as Narrated by Himself*. Henson's autobiography inspired Harriet Beecher Stowe's landmark novel, *Uncle Tom's Cabin*. The most liberal abolitionists felt *Uncle Tom's Cabin* was not strong enough. More moderate abolitionists praised the book for putting a human face on slavery.

According to legend, in 1862 Abraham Lincoln greeted Harriet Beecher Stowe by saying "So you're the little woman who wrote the book that started this great war." Whether that story is true or not, the legend underscores the connection between *Uncle Tom's Cabin* and the Civil War.

In his autobiography, Henson vividly described his experiences living as an enslaved person on the Riley plantation. Although, many of these experiences are recreated in Stowe's famous novel, there are major differences too. Unlike the fictional "Uncle Tom" who was killed by the order of his owner (Simon Legree), Henson escaped to Canada where he established the Dawn Settlement for fugitive slaves (located near Detroit, between Lake Erie and Lake Huron). As a conductor on the Underground Railroad Henson led over 200 people

from enslavement in the United States to freedom in Canada. Henson traveled to England three times to raise money for the Dawn Settlement, and on March 5, 1877, he was invited by Queen Victoria to meet with her at Windsor Castle.



In 1983, Josiah Henson became the first black person to be honored with his likeness on a Canadian postage stamp.


Josiah Henson Park preserves the owner's house and a small part of the plantation property of Isaac Riley. The Josiah Henson Project is raising funds to construct a museum and

educational facility to be located on the property where Henson was enslaved. The museum will portray Henson's life and the Maryland slave experience. It will also explore the impact of Stowe's novel.



REMINDERS ABOUT THE MCPSRA TRAVEL PROGRAM

1. We all travel at our own risk. When signing up for one of the sponsored trips, participants accept all liability for any loss, damage or personal injury related to that trip and hold MCPSRA, its Officers and Board harmless should any accident, injury or loss occur.
2. Itineraries, times and details are approximate. Changes are sometimes necessary and unavoidable.
3. Trips are open to members, their families and friends (adults).
4. Smoking and drinking of alcoholic beverages are not permitted on the coach.
5. PLEASE OBSERVE THE DEADLINES FOR RESERVATIONS AND PAYMENT. We have to make commitments by the dates indicated so this is very important in making a trip go or having to cancel for lack of participation.
6. About three to five days before a day trip, participants are called to remind them of the day and departure time of the trip. For overnight coach trips, about two weeks prior to the date of departure, participants will get a letter with up-to-date information, including parking details. One baggage tag per person will be mailed to each participant.
7. Write a separate check, payable to MCPSRA, for each trip. Include the name and date of the trip on each check.
8. Send your check with your completed reservation form. Your reservation will be definite upon receipt of your deposit/full payment, whichever is required. If a trip has to be cancelled because of insufficient numbers of participants needed by the published deadline, your check will be returned to you. Please feel free to call to find out if your reservation and payment were received.

9. Refunds are made only when your space can be filled.

10. Gratuities for driver and local guides are not included in the price of the trip.

11. We do not provide transportation to and from the airport for trips that require flying.


