
Business meeting/luncheons are held four times a year at the delightful Normandie Farm Restaurant, 10710 Falls Road, Potomac, MD 20854.

TOOLKITS PROJECT

ON HOLD

During this period of great uncertainty and anxiety, there is one thing we can all agree is true... our lives have forever been changed by the COVID-19 pandemic. A new normal will emerge. We are a resilient society that is determined to grow stronger and be prepared and more knowledgeable in the future on how to fight and eradicate diseases that threaten us all. *Hope* survives and thrives with positive thoughts. Although we must remain socially distanced from one another our character and our commitment to children does not change with a virus. We must be drawn together around the education and well-being of our county's children. They ARE our future!

Through our Toolkits Project, in the past sixteen years we as an association have been dedicated to addressing the needs of our county's school children most affected by the economic challenges their families face every day. During those 16 years, we provided over 22,000 kits of school supplies to needy in-coming kindergartners who attended a special Title I summer program called Extended Learning Opportunities Summer Adventures In Learning (ELO SAIL). We were already making plans and working on several tasks at the MCPS Department of Materials Management warehouse in preparation for this summer's program. Then COVID-19 hit and the lockdown followed. That made it necessary to suspend all hands-on work on the project. We cannot resume until all schools and facilities reopen and a schedule of summer and fall school programs is developed and announced. We remained in communication with the Title I coordinators as well as Lanny Taylor at the DMM warehouse. As the weeks passed (then months) it became acutely evident that we had some difficult decisions to make regarding the feasibility of continuing to order the items and boxes for the kits. There was no certainty that the Title I summer school program would even be held. There is no estimate of the number of children that might enroll if it is held.

We are also aware that some items included in the kits may not be available since they are made in China or Japan and that shipping of school supplies is not currently a priority.

As the postponement of children returning to in-school classes continues, it becomes increasingly certain that the demands on Lanny and his staff at the DMM will be to provide supplies for the 208 MCPS schools first once the announcement is made. Therefore, our association's Board of Directors during a telephone conference meeting of 17 of its members on Thursday, May 7, passed a motion to postpone our project until 2021.

The COVID-19's Impact on MCPSRA

The Covid-19 virus has impacted every one of us... from physical isolation from friends and family, to no longer eating in our favorite restaurant; from shortages of household cleaners and toilet paper, to our inability to attend meetings and religious services in person. Our lives have been changed dramatically! You may not be surprised to learn that our Retirees Association has also been dramatically affected as well? Here are some of the significant "changes" MCPSRA has been forced to make due to this virus pandemic.

Impact on Operations and Programs:

- **Scholarships:** MCPSRA has "always" awarded scholarships to MCPS Teachers and Staff for summer study. However, with schools closed, the pure logistics of distributing and processing applications became impossible. In addition, the volatility of the stock market and its significant financial losses had a negative economic impact on our scholarship funds. As such, for the first time in decades, MCPSRA will defer awarding scholarships this year. [See a statement from the Scholarship Committee on page 5.]
- **Toolkits Project:** For more than a dozen years, MCPSRA has provided "toolkits" to incoming kindergarten Title I children attending the ELO SAIL program each summer. This year, however, the MCPS Warehouse is closed. Items normally purchased (such as plastic boxes) are currently unavailable. Summer programs themselves are on hold. Because of all of these factors, MCPSRA reluctantly had to suspend this important project for this year. [See article on pages 3 and 5.]
- **Membership Recruitment:** Every June, MCPS holds a reception for new retirees at which MCPSRA gets to "meet and greet" potential new members. As of this writing, that reception is in limbo as is our participation.
- **Quarterly Luncheons:** As we all know too well, dine-in restaurants are closed. Social distancing thus prevents us from having a membership meeting as part of a fun filled luncheon. MCPSRA has had to cancel its April and June Luncheons. While we hope to resume in October 2020, no one knows what the virus (or the economy) will require by fall.

The Board had approved a Budget for 2020-2021, which was printed in the last issue of this newsletter. It was to be voted upon at the April Luncheon Meeting. That budget reflected increased emphasis on scholarships and projects, as well as a more realistic estimate of dues revenue. To fund that budget, the Board agreed to propose a \$5 increase in our annual dues. However, any dues increase requires a vote by the membership [Bylaws Article IV]. So, thanks to COVID-19 causing MCPSRA to cancel its membership luncheon meetings, there was no way to adopt the proposed budget.

At its May 7 Board Meeting (held by teleconference), the Board rescinded its approval of the previously published draft budget and adopted a revised budget with NO DUES INCREASE. That budget still reflects a realistic estimate of dues revenue, based solely on maintaining our current membership. Hopefully, the economy will recover sufficiently by next spring that MCPSRA can transfer additional funds from the investment accounts to increase the number of scholarships funded by this revised budget. A copy of the revised budget is on page 6.

I'm certain there are (or will be) more impacts on MCPSRA and on us until this pandemic is over. Some say life will never return to the "normal" we were used to last February. My hope is we will return to enough of the normal that has allowed MCPSRA to serve the needs of children and retirees in the past. Until then stay well and stay safe.

Scholarship Report by EA Stonesifer

The 2020 Scholarship program fell victim to COVID-19. Due to the closing of schools and many divisions in MCPS, the appropriate and equitable dissemination of materials and applications became impossible.

In addition, the screening process (which involves the collection of applications, evaluations of each, and interviews of selected applicants by the committee) was not possible during this spring.

The fluctuations of the Stock Market at the time also had an impact on the MCPSRA investments necessary to fund the scholarships.

While the Scholarship Committee was disappointed in not being able to grant the 2020 scholarships, it looks forward to resuming the program in the spring of 2021.


Toolkits (Continued from page 3.)

When schools do reopen, there will be a greater need for our toolkits than ever before. Because of the devastating increase in unemployment and economic downturn in our county and nation, it is our intent to continue our project as soon as possible. (We may have to wait until next summer.) Logistically we cannot provide a kit for every child entering kindergarten in the more than 26 Title I elementary schools this year but we will continue to work with Title I and do what we can. Therefore, we MUST continue our fundraising efforts in anticipation of the increased need for kits in the future. Last summer's expenses exceeded \$29,000. To date approximately \$20,000 has been donated this year. We are going to need considerably more to meet the anticipated drastic increase of kits requested in the future. COVID-19 Is Not the Only Pandemic We've Experienced by Russell Wright

Yogi Berra called what we are experiencing today “*like déjà vu all over again.*” I know that you have survived other pandemics and so have I. According to the CDC, I have lived through 3 of them (1957-58, 1968, and 2009.)

I was born in 1944. In the fall and winter of 1957-58 the Asian Flu pandemic hit the world. It was caused by the H2N2 virus. It struck Montgomery County when I was in the 8th grade at Colonel Joseph Belt Junior High School in Wheaton. The CDC says that the Asian Flu killed 116,000 people in the US and 1.1 million worldwide. (Note that in 1957, the population of the US was about half what it is today. An equivalent death rate today would mean 214,400 deaths.)

I actually remember the Asian Flu. I was 13 when it hit me in the fall of ‘57. I had a fever so high that one night, on my way to the bathroom, I passed out. I remember the year because when I passed out, my right eye struck a light switch as I fell. I woke up with a bright red spot on the white part of my eye (an eyeball

bruise). The spot was still there when I recovered from the flu and returned to school. It made me a celebrity. Everyone wanted to see the bright red spot on my eye.

In 1968, another pandemic struck. It was called the Hong Kong Flu, and it was caused by the H3N2 virus. (Notice the N2? It's there because the H3N2 virus contained part of the genetic code from the Asian Flu that made me a celebrity at Belt Junior High.) The Hong Kong Flu was first spotted in the United States in September 1968. The estimated number of deaths from that pandemic was 1 million worldwide and about 100,000 in the United States. Most excess deaths were in people 65 years and older. (In 1968 the US population was 194.6 million. An equivalent death rate today would mean 168,700 deaths.) The H3N2 virus continues to circulate worldwide as a seasonal influenza A virus.

Our most recent pandemic (before COVID-19) happened in the spring of 2009. It was called the Swine Flu. It was first detected in Mexico and spread quickly across the United States and the world. The Swine Flu killed 12,000 people in the US.

If you are a member of MCPSRA you were probably born before 1957. If you are reading this article you must have survived the pandemics of 1957-58, 1968, and 2009.

I sincerely hope and pray that we all survive the pandemic of 2020 and that it doesn't become known as the pandemic of 2020-21.

MCPSRA Consumer Report by Reggie Ott

Your membership in MCPSRA assures that you are a member of the Maryland Retired School Personnel Association (MRSPA). As a result, you have access to the bi-monthly Consumer Connection Newsletter published by the MRSPA Consumer Education Committee which offers a full array of consumer information.

1. In this unsettling time around this pandemic, it is important that you are wary of contacts from unproven and unexpected email contacts and phone solicitations.
 - Be aware that any contact who asks for personal information, social security number, or any request that you verify information by phone or email should be ignored and deleted immediately. If companies and financial agencies contact you, do not provide information to them over the phone or by email unless the contacts are known and trusted.
 - Fraud is rampant and we must remain vigilant to avoid being duped by agents whose main intent is to take advantage of the unsuspecting.
 - You are encouraged to contact the attorney general or Consumer Protection Office or FTC online at 877-382-4357 to report all fraudulent contacts received.
2. In the August/September edition of the AARP magazine, there was a brief article which highlighted the importance of protecting medical data. It highlighted the following:
 - **Monitor bank and credit card accounts and insurance-benefits statements for costs you didn't incur.** Act promptly to correct records.
 - **Treat your insurance numbers as if they're as sacred, private and as valuable as your SSN.**
 - **Shred any medical paperwork you don't need to retain;** that includes prescription-drug labels.
 - **Avoid revealing on social media any surgery, medical procedure or visit to a specialist.**


